# A FULFILLING EXPERIENCE

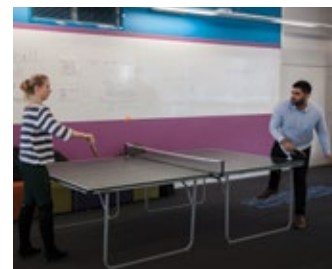

The Law Society reported in June 2017 that 16% of solicitors now come from Black, Asian and minority ethnic (BAME) backgrounds, 57% of whom are women. The gender gap has narrowed in recent years and in 2015/16, 62% of new solicitors were female. The Bar Standards Board reported that of barristers called to the bar in 2015/16, 53% were female and 35% were from BAME backgrounds.

We welcome everyone at The University of Law, with the Student Association Liberation Officer and Women's Officer leading the charge to continually encourage our broad representation of students. We also welcome students from all faiths and those of no faith at The University of Law, which is why each of our campuses has a prayer room free for all to use.

# YOUR ROUTES TO PRACTICE

## THE TRADITIONAL ROUTE TO BECOMING A BARRISTER OR SOLICITOR IS BY TAKING A QUALIFYING LAW DEGREE (LLB)

Alternatively, you can take a degree in another subject and still become a lawyer by taking a one year law conversion course (GDL - Graduate Diploma in Law) or our Masters course (MA Law) after you have graduated.

There is no disadvantage to entering the profession via this route.

You may have heard that the path to becoming a solicitor is going to be changing with the introduction of the SQE assessment. Well don't worry; estimated dates for the new route are not until at least 2020 and any qualifications you start before then will remain valid.

You will be employed as a solicitor apprentice and complete an LLB (Hons) Legal Practice & Skills course over six years.

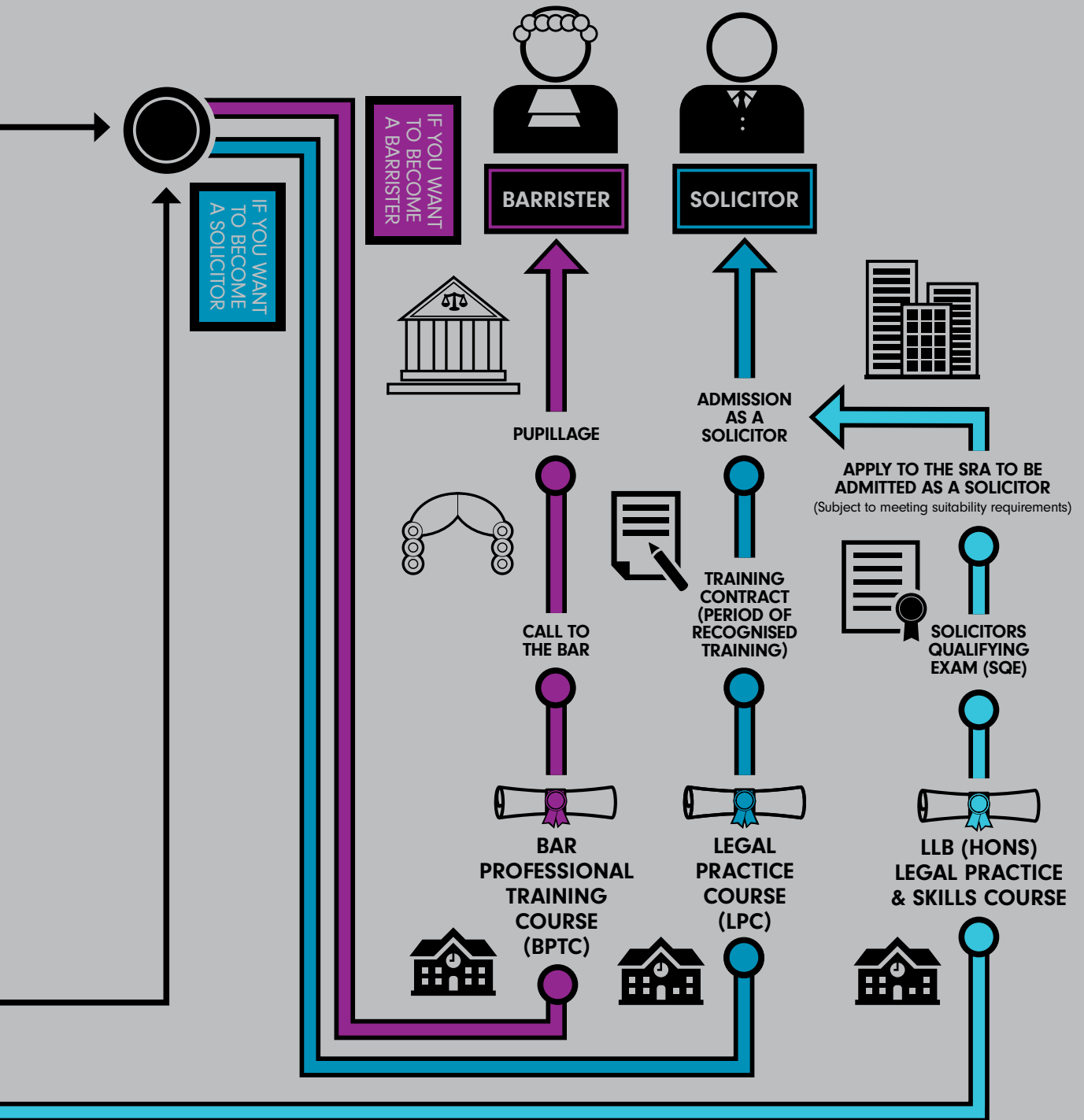

Our courses are designed to ensure you gain a formidable range of essential skills that are welcomed throughout the business world. From working in multinational companies, banking and finance, to technology, media and charities, a legal qualification is highly regarded by employers across a variety of sectors.

You can expect to learn valuable commercial and practical skills, taught by qualified lawyers, often in small group workshops. We also place strong emphasis on individual tutor contact and feedback.

We offer a range of full-time or part-time degree courses, some with a Foundation Year and all of which are Qualifying Law Degrees. We also offer LLB Law degrees with a specialisation in a particular area to give you a head start in whichever career option you choose to pursue, plus as an online course, which allows you to fit your studies around your lifestyle.

An Apprenticeship route gives you the opportunity to earn whilst you learn. As a solicitor apprentice you will complete an LLB (Hons) Legal Practice & Skills course over six years. ## FOUNDATION YEAR

Our four year degrees include an introductory Foundation Year before you progress on to study your three year LLB. This Foundation Year focuses on developing an understanding of the legal sector and the key skills required to undertake the LLB (Hons) Law Degree. It involves the study of six modules to develop the skills necessary to undertake the LLB, and introduces students to key concepts to enable progression onto our three year degree courses.

## PROFESSIONAL RECOGNITION

The LLB (Hons) Law is a Qualifying Law Degree (QLD), which means it's recognised by the Bar Standards Board (which regulates barristers and specialised legal services businesses in England and Wales) and the Solicitors Regulation Authority (which regulates solicitors of England and Wales) for the purpose of exemption from the academic stage of their professional examinations.

## ACADEMIC YEAR

**Year 1:** 31 study weeks including a one week induction

**Year 2:** 30 study weeks

**Year 3:** 30 study weeks

Each year is made up of two semesters consisting of 12 teaching weeks, one week consolidation/revision and two weeks to complete assessments.

The course starts with a one week induction – registration and Freshers’ Week. This week will cover study skills, how you learn on the course and an introduction to employability and legal skills. To get to know your tutors and fellow students, you can also take part in a range of social events and activities.

## ACADEMIC YEAR

# WHAT FINANCIAL HELP IS AVAILABLE TO ME?

## FEES

You may take out a Tuition Fee Loan from the Student Loans Company (SLC) to help pay for the costs of your course. As The University of Law is a privately funded institution, UK and EU nationals can apply for a loan towards tuition fees up to a maximum of £6,165 per academic year for a full-time course or £4,625 per academic year for a part-time course. For courses beginning in September 2018 the University will make a contribution to fees\*, which along with the SLC funding will fully cover the cost of fees, with the exception of the two year Accelerated course\*\*. Arrangements for courses beginning in 2019 are still to be confirmed; eligible students will be able to fund the full fee amount via the SLC and/or a University Contribution to Fees\*. The loan is not means tested which means all students will be entitled to this support, unless you already have a degree qualification.

## HOW DO I PAY MY FEES?

You can pay your annual fee in a lump sum just before you start studying with us in September, or you can pay in instalments. These instalments are equal in cost and are paid at the start of each term. If you decide to take out a Tuition Fee Loan, The University of Law will be able to collect the value of the fee loan directly from the Student Loans Company, provided that you confirm your individual student support number with the SLC.

## MAINTENANCE SUPPORT

Also known as living cost support, if you're on a full-time course you're able to apply for maintenance support to help you with your living costs – i.e. accommodation, food and travel.

The amount you receive is affected by your household income and circumstances, and where you reside within the UK prior to starting your University of Law course. Unfortunately, EU and part-time students are not eligible for living cost support.

The Maintenance Loan is not required to be repaid until you have left the course and are earning an income.

To see the full amounts that could be available to you, use a student calculator. You will then be able to work out how much you are entitled to and what the repayments may be.

## REPAYING MY LOAN

The main things you need to know about repayments are:

- You don't start repaying your student loan until you're in work and earning over £25,000 a year
- Your Tuition Fee Loan and Maintenance Loan are added together so you repay both at the same time
- Repayments are automatically deducted through the tax system
- Outstanding payments are written off after 30 years
- Repayments are affordable and easy to manage – you only repay 9% of your income over £21,000
- You should be aware that these details, your repayment arrangement options and related terms and conditions may change in accordance with the Government's student loan policy.

## SO HOW DOES IT WORK?

Repayment is based on your ability to pay rather than how much you owe. So the more you earn, the more will be deducted from your pay packet and therefore the more quickly you will pay off your loan. If at any point you stop earning – such as if you decide to go travelling – or if your earnings drop below £21,000, your repayments will stop.

## WHAT MIGHT I PAY BACK PER MONTH?

This depends on your earnings. If your income is £27,000 you would repay £15 per month.

## IS THERE ANY INTEREST?

The Student Loans Company will charge interest on your loan but it is lower than an ordinary loan. While you're studying, interest is charged at the rate of inflation + 3%. In the April after your course finishes, the rate of interest will depend on your earnings. This will be a maximum of RPI +3%. ## SCHOLARSHIPS

The University of Law has one of the most comprehensive scholarship schemes in legal education, whether you are a UK, EU or International student. For the current year we are offering over 100 awards and a £600,000 fund across our undergraduate and postgraduate courses.

## INTERNATIONAL STUDENTS

International students pay slightly higher fees. The two year course costs £15,500 per year and the three year course is £13,000 per year. If you're an international student, you won't be eligible for the UK government funding scheme. However, your local British Council office can provide you with details of scholarships and other sources of funding that you can apply for. If you require a Tier 4 Student visa, we must issue you with a Confirmation of Acceptance for Studies (CAS) before you can apply for your visa. You will need to pay £3,000 by way of pre-payment of your Course Tuition Fee before The University of Law can issue your CAS. You will receive an email from our admissions system asking you to make this payment, once the University has confirmed you are eligible for Tier 4 Sponsorship.

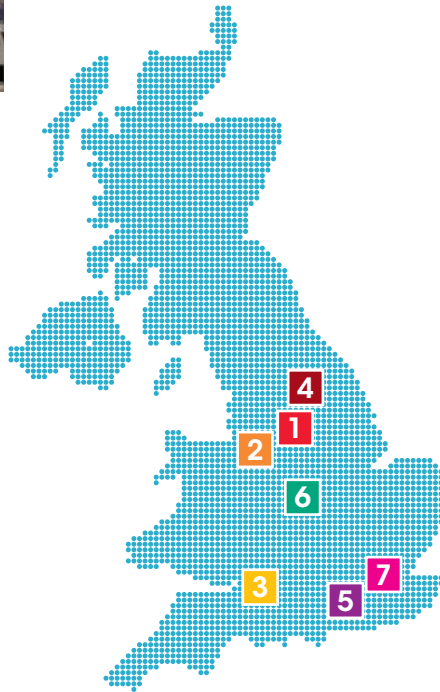

We've arranged accommodation for our undergraduate students with specialist UK student accommodation providers to ensure you have a comfortable place to live while you're studying with us.

### OUR ACCOMMODATION

Accommodation is usually in shared flats or, in some cases, self-contained studios. Flats are normally shared with three to five other undergraduate students. Typically you'll have a shared kitchen/dining room, including fridge-freezer, oven, hob, dishwasher, kettle and microwave. There's usually a separate shared lounge area with comfy sofas and TV.

You'll have your own fully-furnished bedroom, which will typically include a study area and en-suite bathroom. Most locations have laundries and some have on-site gyms.

\*Arrangements for the Guildford campus are subject to change, please check the website for further information. Also please note if you apply after 31 March 2019, we will provide support to help you find suitable accommodation, but cannot guarantee this will be successful. Our guarantee of an offer of accommodation may either be at any advertised accommodation provider, subject to availability, or, in the event that the advertised accommodation provider is not available, we shall guarantee you an offer of accommodation at an alternative UK student accommodation provider. Please note that applications from students under 18 years of age are considered on an individual basis in collaboration with our third party accommodation providers.

### SECURITY

Security is taken seriously at our accommodation sites. Door entry and intercom systems restrict access and CCTV surveillance gives added protection. Most accommodation sites have dedicated management staff available on-site to help you. For further assistance, some locations have student wardens, usually second-year students who are happy to provide extra support, especially if you're living away from home for the first time.

### ACCOMMODATION COSTS

Accommodation costs vary depending on location. As an indication, weekly rental costs for 2017/18 are around £305 per week in London and £125 to £190 per week for locations outside London. For the most up-to-date information see our website:

Studentpad provides helpful advice on choosing a suitable property and local information about things to see and do around your campus. The website is available in multiple languages to assist international students and includes useful web links and tips for living in the UK. Once you've selected us as your first choice on UCAS, you'll be provided with the password to search our property listings. Property listings will vary by campus but typically include student accommodation with private providers, private sector rentals from estate agents and individual landlords and rooms with a landlord-lodger arrangement.

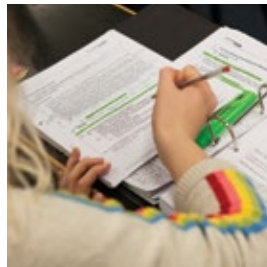
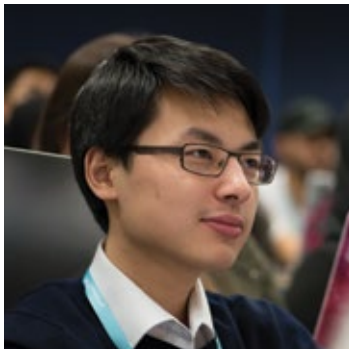

## ENGLISH LANGUAGE REQUIREMENTS

To ensure suitability for both student and course, we ask all international students to provide evidence of English Language proficiency, demonstrating the following (dependent on duration of LLB course) IELTS (academic):

### **LLB course duration 3 years**

Average score 6.5 in IELTS, or equivalent, with no one component being below 6.0 in the four assessment areas of reading, writing, listening and speaking.

### **LLB course duration 2 years**

Average score of 7.0 in IELTS, or equivalent, with no one component being below 6.5 in the four assessment areas of reading, writing, listening and speaking.

### **LLB course with Foundation Year duration 4 years**

Average score of 6 in IELTS, or equivalent, with no one component being below 5.5 in the four assessment areas of reading, writing, listening and speaking.

## ENTRY REQUIREMENTS

**All three year full-time LLBs (including those with any specialist subject) and the four year online i-LLB:**

Three A Levels at grades BBB, plus GCSE English Language and Maths at grade C or 4 or above, or equivalent qualifications.

**Full-time courses with a Foundation year:**

48 UCAS points from a maximum of three A Levels, plus GCSE Maths at grade D or 4 and GCSE English Language at grade C or 4 or above, or equivalent qualifications.

An interview with an academic is also part of the admissions process for this course, either face-to-face or over Skype.

**Accelerated LLB:**

Three A Levels at grades ABB, plus GCSE English Language and Maths at grade C or 4 or above, or equivalent qualifications.

**Apprenticeships:**

Three A Levels at grades CCC, plus five GCSEs including English Language and Maths at grade C or 4 or above, or equivalent qualifications.\*
