STUDY OPTIONS

There are many reasons why you may wish to pursue postgraduate study.

- You have enjoyed your subject at undergraduate level and want to explore it further.
- To gain a specific required qualification and progress your career in a certain direction.
- For intellectual stimulation and enjoyment.
- To develop your theoretical and intellectual knowledge of an area you have good experience of and thus to stand out in your current role.

Marjon offers a variety of postgraduate study options to fit in with all of these motivations.

Levels of postgraduate study

Taught postgraduate degrees are built up with credits. Some programmes allow you to exit once you reach a certain level, for example a Postgraduate Certificate typically comprises 60 credits of study, a Postgraduate Diploma 120 credits and a Masters 180 credits. On some programmes, credits gained during previous study might be counted towards your Masters qualification.

Teaching is typically through a blend of learning including small seminars and tutorials, online learning, hands-on lab or practical research, placements, as well as a significant element of independent study. All postgraduate study will develop your research skills to a high standard.

Postgraduate degrees

These qualifications include MBA, MA and MSc and are taught through a variety of means including lectures, seminars, one-to-one discussions, group sessions and work-based learning. They might be taught face to face or through blended and distance learning.

Full time options usually take a year to complete, and part-time options vary. If you are looking to continue in your career and study at the same time, it is always worth discussing with the Programme Lead how the options will be taught to understand how it might fit into your work and home life.

Our Masters in Research degrees (MRes) are flexible programmes which include a taught component as well as a significant research project. These programmes allow you to work very flexibly and independently but with the support of a research active academic community. Taught modules will allow you to develop advanced research and analytical skills and to explore ideas and issues of most interest to you and of relevance to your future career.

We also offer advanced PhD and MPhil study in areas across sport, health and wellbeing and education (see page 34 for further information).

Teacher training

We have partnerships with schools across the South West to offer comprehensive postgraduate teacher training. Our options are PGCE Primary and Secondary (with various specialisms), School Direct salaried, available on certain specialisms and School Direct non-salaried. For more information about these choices turn to page 52.










We are located in Plymouth, Britain's Ocean City.

Accommodation

Many postgraduate students choose to live at home, however if you choose to stay on site we have a student village on campus with 38 student houses.

We understand that many postgraduate students go on placement so we can offer a 43 week contract (the duration of your course) with a break clause. So, if you do find your placement is more than 30 miles from campus or more than a 30 minute commute you can break your tenancy for the period of your placement and not pay for this time.

Benefits of living on campus include:

- Owned and managed by the University so no surprise fees.
- Rates include heating, lighting, Wi-Fi access, computer support and personal contents insurance.
- A safe environment with 24/7 on campus support.

LIBRARY


TECHNOLOGY ENHANCED LEARNING



You don't need an appointment; you can just come and talk to us. Together with the SU and student support we run a 'listening post' to help students who need a practical, non-judgemental ear.



As we prepare for the Research Excellence Framework 2021, we are actively encouraging research-active staff and students to join our community.

Sport and Health research

Across the Faculty of Sport, Health & Wellbeing, we undertake research which advances knowledge in physical activity, exercise, sport and rehabilitation, and which is related to human health, performance, social inclusion and sustainability. In addition, health topics such as musculosketal health, dementia, diabetes and age-related diseases have been studied and reported in peer-reviewed journal publications.



Students are easily able to get involved in our research due to our position at the centre of a sporting community. The popularity of our facilities enables us to attract external collaborators and professional athletes and sports teams to work with as well as helping us recruit participants from the community to research studies. We enjoy sporting collaborations with Plymouth Argyle FC, Plymouth Raiders professional basketball club, plus several nationally renowned swimming and diving clubs.

Faculty staff provide sports science clinic support to elite athletes, which has the added benefit of giving students fascinating insight and hands-on experience during their vocational courses.

The faculty runs a Cancer Care clinic and an NHS back pain clinic, delivering GP exercise referrals locally. Other GP referral clinics include clinics for sports injury, obesity, diabetes and leg ulcers.



Speech Therapy research

The Speech & Language Therapy (SLT) team have links with Parkinson's UK at local and national levels, The Stroke Association, Connect Support Cornwall, Hannahwood Trust, the West of England Gender Identity Clinic and many more. SLT team members are regularly asked to contribute to, edit and co-author research pieces and articles for publication.

Education research

Our founding mission was to tackle inequality and develop opportunity through education. Remaining true to our origin and values base, the University continues to undertake critical educational research that is sector leading, informs debate, addresses policy development and improves practice in relation to educational inequality. We work closely with the Department for Education and wider government agencies to influence educational policy at a national level and provide solutions for educational challenges.

Our research is in both formal and informal education and is articulated through our research cluster 'ACE' – Agency, Context and Education. The research in ACE brings together interdisciplinary researchers to work together through an educational lens. Funded research ranges from Youth Work to Maths Teaching, from Teacher Retention to Outdoor Education. Pushing boundaries in methodology, theory and practice, educational research in Marjon is innovative; bringing new understanding to inform policy and practice nationally and internationally.



I have enjoyed an international academic career for the last 20 years, researching how muscles contribute to health and wellbeing.

Skeletal muscle research benefits the greatest number of people by advancing knowledge and innovation to prevent or remedy muscle weakness, injury, disease and ageing effects.

After a recent news piece on our EU-funded international network we were flooded by emails, phone calls and letters from the public – one from a 93-year-old - and health allied professionals. Statistics and research show that muscle weakness is still an unmet medical and societal challenge. Such instances of overwhelming response justify my choices so far and motivate my future work.

RESEARCH IN ACTION

Finding the evidence to better support young people

Marjon Social Scientists are coordinating an Erasmus Plus project across Europe investigating the positive impact of youth work. By comparing how youth work is supported, funded and run across different European states, and investigating the impact, the project will provide vital evidence needed to level the playing field of inequalities in Youth Work Services across Europe.

The project will roll out across the UK, France, Italy, Estonia and Finland. The method involves young people directly in the process of evaluation by asking them what difference youth work has made to their lives. The changes are expected to be many and varied and include changes in their outlook and aspiration, significant growth in confidence, as well as academic achievement, or gaining employment. It may also reflect the resolution of problems such as overcoming bereavement or an addiction.

It is hoped that data on the impact of youth work across Europe will be collated into research that Government policy makers cannot afford to ignore.

Tackling muscle disease

Academics within our Health and Wellbeing team are coordinating a project across 14 European academic and industry organisations investigating muscle disease and how we can better support patients.

Skeletal muscle loss and dysfunction, including weakness, is increasingly becoming an unmet health issue with far reaching consequences: chronic renal, or cardio-metabolic disease, as well as ageing and/or unhealthy lifestyles, even among the young, all leading to muscle mass loss and functional deficits. Sufferers have an increased risk of a fall, need to restrict their mobility, and acquire further comorbidities. All of these result in low quality of life, increased societal and healthcare costs, disability and premature death.

The research includes investigating innovative solutions such as how exercise or pharmaceutical interventions might be used to provide better muscle conditioning in the aging population and prevent fractures.

Exercise as medicine


Within the Health and Wellbeing department, we run a holistic physical activity clinic for cancer patients, and underpin this clinical work with important research. The work with the clinic aims to improve quality of life, working on not just the physical effects of cancer, but the familial and social aspects too. The resulting research makes an important contribution to our understanding of this area of exercise as medicine.

Giving voice to transgender clients

Marjon has an outstanding reputation for professional Speech and Language Therapy training and we are underpinning this with academic research. Expertise includes Parkinson's, Dementia, Cerebral Palsy and in particular transgender voice, where the University is leading the way in the use of singing as part of voice transition. As part of this work, Marjon will form part of one of only seven multi-disciplinary gender clinics in the UK.

Developing community values in children

Our researchers were requested by the Department for Education to evaluate a multi-institution project looking at the efficacy of a 'What If?' learning pedagogy. This learning theory is aimed at developing 'character' at school age, to help foster respect, tolerance, community spirit and neighbourliness. It's hoped that the research will lead to new and innovative ways to teach common values from a young age.





Leading the debate on educational challenges for coastal schools

Leading the field on educational research on coastal schools, our findings have impacted on national and international perceptions of educational disadvantage in coastal regions in England. Most recently this research was cited by the Social Mobility Commission in The State of the Nation Report (2017), demonstrating the difference for Cornwall that this research had made. The coastal schools research is now being extended to explore the complexity of educational isolation from an international perspective.

Contributing to solutions for teacher recruitment and retention internationally

Following the successful Education Endowment Foundation funded evidence based and research informed intervention to 'RETAIN' Early Career Teachers in England, and a successful British Education Research Association supported conference on the challenge of teacher recruitment and retention in England, the lead for these initiatives has been invited to Chair the International Council for the Education of Teachers (ICET) World Assembly Research Roundtable on Teacher Recruitment, Retention and Development in July 2018. The roundtable will produce a task list that will be supported by ICET and inform international activity challenging and supporting the crisis globally in teacher recruitment and retention.



PhD and MPhil

You can undertake research study with Marjon across three areas; sport and exercise, health and wellbeing and education.

In these routes you will work with a supervisor but the subject of your research and the majority of your work is self-led. If you are interested in undertaking study at this level, the first step is to contact the Research office and start an initial discussion with an academic supervisor.

Our research degrees are all awarded by the University of Chichester.

Education

This area encompasses the full range of sectors of informal and formal education and addresses education pedagogy, policy and practice. The group has developed innovative impacts on education pedagogy, policy and practice in early years, community, school, further, higher and career-long education at local, regional, national and international levels. A strength of the group is its interdisciplinary approach, encompassing particular strengths in sociology and psychology, and its work across all areas of initial teacher education.

Health and Wellbeing

The subject grouping includes Speech & Language Therapy (with an NHS-commissioned programme and patient referral clinics), physical activity (clinics), mental health, musculoskeletal health, sports medicine, and regenerative medicine. Interdisciplinary studies that develop the role of creative, digital, or technological interventions or communication vehicles in health and wellbeing are also of interest to the University.

Sport and Exercise

This area focuses on research that advances knowledge of how physical activity, exercise, and sport are related to human performance, social inclusion and sustainability. Within human performance, research includes investigation of physiological, psychological and mechanical factors across training, recovery, injury repair and rehabilitation to facilitate better understanding of the fundamental principles underlying performance.




INTERNATIONAL STUDENTS


CPD for educational professionals

We now offer continuing professional development for educational professionals in Cornwall from our new base in Truro. Marjon University in Cornwall is located in The Old Cathedral School, next to Truro Cathedral. We will continue to offer in-school support, along with opportunities for schools and colleges to request bespoke CPD that supports their improvement and development plans.

Length and mode

One year split in to two six-month blocks.

Delivered on around seven to eight Saturdays a year.

Requirements

A 2:2 or above honours degree.

To be engaged in paid or voluntary work (full or part time) where coaching and/ or mentoring is or could be undertaken.

English language level of IELTS 6.5 for international students.

Non-standard applications are also welcome and careful consideration will be given to those who can present a case based on their career history, experience and other learning.

This programme is designed to challenge and develop those who use coaching and mentoring in their current roles, or who want to move into this profession.

The programme attracts a diverse range of professionals, in the past including people from youth and community work, business, leadership and management, the armed forces and early years education backgrounds. There are few roles in which this expertise can't be put to good use.

Because of the diversity of students' backgrounds, the programme naturally allows participants to explore the principles of coaching and mentoring within a variety of settings, as well as applying new skills to their own role. The programme's general environment is dynamic and interactive, and students are encouraged throughout to share and explore ideas.

Careers

Following the programme, students might find themselves taking up mentoring roles with new colleagues; acting as subject mentors in initial teacher education; coaching colleagues in a range of settings; providing supervision for colleagues or even working freelance as an independent coach.

Our unique MRes in Communication Disorders is designed for skilled practitioners already working in health, education or social care, who wish to develop their interest and expertise in research, to become confident evidence-based practitioners.

This programme will be of interest to clinical/educational colleagues who wish to develop their knowledge and understanding of communication disorders in different contexts for example, children with developmental speech and language disorders. It will also be of interest to practitioners working with adults with communication disorders, for example, within the justice system, or as a consequence of dementia or following a stroke. The current Speech Language Therapy team includes experts in developmental speech sound disorders; motor speech disorders; Augmentative and Alternative Communication; transgender voice; voice disorders; acquired dyslexia and dysgraphia; dysphagia; aphasia; bilingualism; literacy; learning disabilities and both quantitative and qualitative research methodologies, and therefore can accommodate colleagues with interests in these areas.

Careers

Development of specialist knowledge with the potential to support others in your profession. This will provide an excellent CPD opportunity and/or a good foundation for further research, for example, a PhD; research advisor for your specific profession; developing as an academic in Higher Education.


It is anticipated that applicants will be graduates, and may already be engaged in work within the profession. MRes English Literature is an individual project based Masters programme. This programme will place you at the cutting edge of English Literature by enabling you to research current theoretical and contextual issues and debates through individually tailored projects. The programme is designed to meet the needs of both graduates who are seeking to specialize in English Literature, and teachers wishing to engage in further professional and academic development.

The programme incorporates research workshops and is structured around a flexible though clearly framed series of three supervised projects, and can be taken over one, two or three years.

Projects undertaken by past and current students on the programme include, for instance, neo-Victorianism and Steampunk, Haunting in Contemporary Women's Writing, Contemporary Issues of Censorship, Feminist Critical Theory, Orwellian Discourse, Romantic Childhood, and Trauma Theory and Holocaust literature. In each case an appropriate project focus is agreed with a supervisor with relevant expertise and interest, who will help you to structure your research and writing at this level.

This include areas such as adventure tourism, outdoor education, outdoor learning, outdoor recreation, forest schools, summer camps, youth programmes, adventure racing, adventure sports coaching, national governing bodies, leisure facilities management, and outdoor retailers and manufacturers. 





This Postgraduate Diploma in Early Years with Initial Teacher Training (EYITT) is often fully funded by the government (awaiting confirmation for 2018), and leads to Early Years Teacher Status – a qualification which is growing in popularity. People who hold this status are leading professionals in the provision of services for children aged up to five. The course runs on campus over three blocks of one week each, alongside learning within a work setting.

The Early Years Initial Teacher Training (EYITT) programme can follow two routes, each developed to meet a range of needs.

Route one:

Postgraduate Diploma in Early Years with EYITT (GEE)

If you are already working in an early years setting, this route will work for you. It is also known as the Graduate Entry Employment-based route. Financial support is usually available to employers to release staff to attend this programme.

Route two:


Postgraduate Diploma in Early Years with EYITT (GEM)

Designed for graduates in any discipline, this route is ideal for those who've decided to change careers, or new graduates with an interest in early years education. The programme is fully funded by the National College for Teaching and Leadership and small bursaries to support your day-to-day living may be available for eligible candidates. It's also known as the Graduate Entry Mainstream route.

Successful completion of the programme results in the award of Postgraduate Diploma in Early Years with Early Years Teacher Status. Typically, students find employment in Children's Centres, nursery classes in schools, private and voluntary-funded nurseries or working in Local Authority early years provision. Many students go on to complete a dissertation to gain their MA (Education).

I completed a science degree in London and I loved that but realised my true passion was teaching. So I came to Marjon and did a postgraduate teacher training course. When you ask anybody why they love teaching they all say that it's that interaction with children, that lightbulb moment when you realise 'you've got it', when they suddenly understand a new concept.

I love hearing back from trainees a few years down the line, when they become head of department or they are in the senior management team in a primary school. It's nice for us to know that they have started their journey here and through their own hard work and their enthusiasm, they are making progress in their own lives and also making a difference to others.

This School Direct programme trains you in one year to become a Newly Qualified Teacher. You will be based out of two different schools across the year, immersed in school life and taking an active role in the school team. You will work mainly out of a lead school, with an additional placement for six to twelve weeks to give you breadth of experience. You choose to train to teach across a specific phase, depending on our partners each year; early years, primary or secondary.

Some training will be school-based, led by teachers and working with other trainees from other schools, and you will also attend University and be part of a broad cohort of University students.

The assessments not only review your knowledge but offer the opportunity to develop skills for the modern workplace.

This MSc Psychology explores the key areas of psychology: cognitive, biological, developmental, social, individual differences and psychological research methods, plus you will complete an independent project and research dissertation.

Careers

Your psychology degree will give you the transferable skills that employers want, whether you are looking at private or public sector careers. It is also a first step towards a career in educational, forensic, clinical, counselling or sports and exercise psychology. It can lead to a career in academia or research through starting postgraduate study and developing to a phD programme.

Working with



Public Health England Public Health is an interdisciplinary area which aims to prevent disease, prolong life and promote health. It addresses broad issues that can affect the health and wellbeing of individuals, families, communities, populations, and societies.

This Master's-level programme is aimed at graduates and professionals from a range of backgrounds and will develop your knowledge, skills and capabilities in key areas such as health surveillance, intervention, leadership and policy development.

The programme is both for students who want to enter the field of public health and for those already working as a health professional who want to progress their career. There will be opportunities to engage with employers and real-world projects and for those already in employment there will be opportunities to network and develop their understanding and competences.

The Master of Public Health (MPH) is a 'specialised' Master's degree in that it has academic and professional elements, taking an interdisciplinary approach to areas related to public health. Students are taught how to monitor, diagnose and regulate the health concerns of communities through public policies.

The full-time programme will be normally delivered in block on two days per week and the part-time route normally on one day a week. We have aligned the MPH with Agency for Public Health Accreditation (APHEA).

Careers

Graduates will be well placed to apply for public health roles in local or national government health departments. The range of jobs varies widely, and can include epidemiology, environmental health, health education, health promotion, health policy development, research and health advocacy.

While studying, students on this programme can apply for student membership with The Royal Society of Public Health and upon completion of the programme students will be eligible to apply for a fellowship membership.

Through this programme you will gain a comprehensive understanding of the research interests at the cutting edge of sport and exercise psychology. You will learn the core aspects of practising sport and exercise psychology as well as the considerations for training and developing sport and exercise psychology practitioners. A core aspect of this programme is the practical application of subject knowledge that underpins all modules.

The MSc in Sport and Exercise Psychology is designed to support people interested in pursuing a career in sport and exercise psychology through the British Psychological Society (subject to accreditation) and the British Association of Sport and Exercise Sciences, however it is suitable for people interested in sport and exercise psychology who have different career ambitions.

The programme hosts a variety of modules specific to both applied and academic development and interests including psychological skills and therapeutic skills in sport and exercise; contemporary interests in sport and exercise psychology; and professional development in sport and exercise psychology. There will be opportunities for students to work with qualified sport and exercise psychologists with a wealth of practitioner experience.

Careers

A career as an accredited sport and exercise psychology professional can follow two routes: the British Psychological Society (BPS) route and the British Association for Sport and Exercise Sciences (BASES) route. Sport and exercise psychologists applying psychology in sport contexts could assist athletes in preparing for the demands of training and competition, provide support for mental health issues, and help athletes cope with injury and retirement. Applying psychology in exercise contexts helps to increase and sustain participation in exercise in the general public, encouraging a lifestyle that benefits health and wellbeing. Outside of sport and exercise, psychology has application to a wide range of employment contexts, such as coaching, health and fitness, education, and the military.

Length and mode

One year full-time or up to 60 months part time, delivered in the evenings (4pm-7pm), through individual tutorials and through distance learning.

Requirements

Normally an upper second class honours degree or equivalent, but applications will be reviewed on an individual basis.

International students must have an IELTS score of 6.

This intellectually stimulating Master in Research programme allows students to develop their career in sport and health through a critical appreciation of contemporary issues and developments within the field. Through critical reflection it equips students with the skills and knowledge to plan for these changes, implement them and deal with any challenges.

This programme is project based and work centred, providing a particularly responsive alternative approach to professional development that is rooted in the concept of action research and encourages students to explore issues as they emerge.

The University has the only British Association of Sport and Exercise Sciences (BASES) accredited laboratory in the South West and students will have access to these facilities to complete their studies. Students will also have the opportunity to work with elite and young elite athletes. Students will attend the Faculty research seminars which feature leading national and international academics presenting on various topics within the discipline of sport and exercise science.

The programme is structured around a flexible though clearly framed series of supervised projects. There are three x 60 credit modules delivered through lectures, seminars, individual tutorials and distance learning. Each project focuses on a clear theme which is key to a critical appreciation of the professional area and has its own qualification outcome. There are various pathways within the MRes programme, including:

- Sport and Exercise Medicine
- Sport and Exercise Science
- Sport and Health Sciences
- Sport Development
- Sport Management

Careers

This research driven programme enables professional development within Sport and Health Sciences. Your programme will reflect your own professional aspirations and increase your potential to progress with your current employer or within the wider sector. Career progression to PhD, management positions in sport and exercise support, sporting NGB's, exercise and fitness professionals working in the private sector, National Health Service (NHS) - exercise professionals in preventative and rehabilitative treatment via exercise.





SPORT REHABILITATION

MSc

Sport Rehabilitation is a dynamic profession focusing on understanding, preventing and treating sport and exercise related injuries. It takes an evidence-based approach considering anatomical, physiological, biomechanical, and psychosocial factors. The programme aims to provide graduates from a sports science background with the knowledge and application of the musculoskeletal system, enabling them to clinically assess and return athletes to full functional fitness through expertly developed evidence-based rehabilitation programmes. Students will develop key practical skills in our teaching clinic and world class sports science laboratories and we blend this with online technologies to enhance remote study. Intense teaching periods provide students with opportunities to apply and develop their knowledge through work-based learning in our sports injury clinic. A minimum of 400 clinical hours of hands-on experience will be obtained in our Sports Therapy and Rehabilitation Clinic.

In addition, students undertake professional work placements with our partners to broaden their experience. Graduates will be eligible to join the British Association of Sport Rehabilitators and Trainers (BASRaT) (pending, subject to validation). Foundation clinical and rehabilitation skills are developed through a blended learning approach. Students will obtain the RFU Immediate Care in Sport qualification. This is a new programme starting in 2017.

Careers

There is a growing demand for Sport Rehabilitators to work alongside other healthcare professionals or as autonomous practitioners.

This programme is for those considering careers within professional sporting environments, the Ministry of Defence, sports injury clinics, sports clubs and the health and fitness industry.

FEES AND FINANCE

Postgraduate Loans

Loans are available from Student Finance England, for students in England to apply for, who are starting an eligible postgraduate Master's programme in 2018. This is a nonmeans-tested loan of up to £10.280*. There are alternative schemes being introduced across Northern Ireland, Wales and Scotland.

How it works

The loan is paid directly to the student. You can choose how you use it to pay your programme fees and living costs.

Loans are spread across the length of the programme and paid in installments, and you can find details of this online.

Repayments will be calculated at 6% of any income you earn over the threshold (currently £21,000). Repayments will start the April following programme completion, subject to meeting the annual income threshold.


Criteria

The loans are only available if you have not already completed a postgraduate Masters qualification or a higher level qualification like a PhD. There are various eligibility criteria for the loan from SFE, including:

- You must be a UK or EU national or have settled status.
- You must normally live in England (ie. not have moved to England purely for the purpose of doing a postgraduate programme and receiving a loan), and have been living in the UK for at least three years before the start of your programme.
- You will have to be aged under 60 before the first day of the first academic year of the programme.

Teacher Training

PGCE and Schools Direct (unsalaried) can receive funding from SFE and can apply for the same type of funding as undergraduate students - Tuition Fee Loan, Maintenance Loan (standard amount and higher income assessed amount) and any relevant grants.
